General Situation

In the findings of the 2001 Census of Manufacture completed on December 31, 2001, the number of manufacturing establishments with 4 or more employees by commodity and their value of shipment were compiled by industry and prefecture.

1. Number of establishments

When observing the number of manufacturing establishments by commodity, the largest figure was seen in planograph (offset) printing, followed by lumber and wood products-related commodities including miscellaneous fabricated plate and sheet metal products, fittings other than metal fittings, boards, squares and lumber, and food-related commodities. When comparing the number of establishments with the previous year, the number of establishments shows a decrease in the top 52 commodities.

The number of establishments for planograph (offset) printing is high in "Tokyo", "Osaka" and "Aichi". The sum of the 3 prefectures composes 30% or more of the total. The number of establishments for miscellaneous fabricated plate and sheet metal products is high in "Osaka", "Aichi" and "Kanagawa", where the total of the 3 prefectures amounted to approximately 30% of the total number of establishments (Table 1).

2. Value of Shipment by commodity

By commodity, the value of shipment automobile-related commodities including ordinary passenger cars and light and small passenger cars was highest, followed by information technology and communications-related commodities including personal computers, miscellaneous electronic parts, and cellular and PHS telephone sets (Table 2).


Furthermore, rankings for cellular phones and PHS telephones and truck bodies rose from 18th and 32nd in the previous year to 15th and 27th respectively.


Compared to the previous year, the value of shipment has decreased in 1,294 commodities, or approximately 72% of the all the commodities, which is far above the 52% ratio of decreasing commodities of the previous year.


The value of shipment has fallen way below the value of the previous year in information technology and communication-related commodities including metal oxide semi-conductor IC, miscellaneous electronic parts, and silicon wafers.

On the other hand, when observing the commodities that have increased, though many are transportation-related or information technology and communication-related, the commodity that increased the most was pharmaceuticals, and sparkling alcoholic beverage "happo-shu" and "tea drinks (Japanese tea)" were also quite significant.






3. Value of Shipment by commodity and by industrial sub-classifications

When observing the value of shipment by commodities by industrial sub-classifications,


(i) In the "beverage, tobacco and feed industry", the value of shipment for tobacco and beer are decreasing, whereas it is continuously increasing for sparkling alcoholic beverage "happo-shu" as well as in beverages including low grade distilled spirits, tea drinks (Japanese tea) and coffee drinks including coffee with milk.




Transition in value and volume of shipment of alcoholic beverages


- (ii) The value for shipment "apparel and other finished products made from fabrics and similar materials" has dropped in all commodities due to the increase of imported goods.
- (iii) In the "chemical industry", medical preparations have increased for new medicine and the value of increase is largest among all the commodities being manufactured.
- (iv) In "petroleum and coal products", the price of petroleum products have increased on the increase in the price of crude oil and the value of shipment as increased in all commodities compared to the previous year.



- (v) Rolling of aluminum products in "non-ferrous metals and products" has increased on the increase in demand for cans for beverages.
- (vi) Aluminum sashes for buildings in fabricated "metal products" has increased on the increase in construction of buildings related to the redevelopment of station fronts.




(vii) In "general machinery", among semiconductor manufacturing equipment, the value of shipment for treatment equipment for wafer process (electronic circuit forming), assembly equipment and miscellaneous semiconductor manufacturing equipment have decreased.


(viii) In "electrical machinery, equipment and supplies", metal oxide semiconductor IC, personal computers, electronic parts and liquid crystal elements with significant value of shipment have all decreased whereas the value for cellular and PHS telephones increased.




Transition in value of shipment for top commodities in electrical machinery, equipment and supplies



3. Top ranking commodities by prefecture

(1) Number of establishments by commodity

When viewing the number of establishments by prefecture, "planograph (offset) printing" ranked 1st in 19 prefectures (19 prefectures in the previous year), followed by "lumber products" which ranked 1st for boards in 7 prefectures and squares in 4 prefectures.

In addition to those prefectures, various specialties ranked 1st in each prefecture. For example, "dried seafood products, salted and dried seafood products, boiled and dried seafood products, salted seafood products" in "Hokkaido", "cut-stones and stoneware products" in "Ibaragi", "frames" in "Fukui", "precious metal products including jewels, ivory and turtle products" in "Yamanashi", "green tea (processed)" in "Shizuoka", "Japanese noodles including "*udon*" noodles and "*somen*" noodles" in "Kagawa" and "Nagasaki", "towels (except handkerchiefs)" in "Ehime", "Japanese-style ceramic tableware" in "Gifu" and "Saga", and "semi-processed green tea" in "Kagoshima". These were the top ranking commodities nationwide (Table 4).

(2) Shipment value by commodity

When observing commodities with the highest shipment value by prefecture, "medical products preparations, including preparations outside medicines" and "gasoline" both ranked 1st in 7 prefectures, "tobacco" in 5 prefectures, "ordinary passenger cars" in 4 prefectures and "light and small passenger cars" in 3 prefectures.

There were 10 prefectures in which electronic communication equipment-related products ranked 1st, "Metal oxide semiconductor IC" was 1st in 3 prefectures, "personal computers" in 2 prefectures, "fixed capacitors" in 2 prefectures, "data processing machines", "digital and analog computers, equipment and accessories as well as printer" and "liquid elements" in 1 prefecture.

Observing the commodities ranking from 2nd place on, electronic communication equipment-related products are all top ranked in each prefecture.

In prefectures where automobile-related products rank 1st, there were 4 prefectures in which "ordinary passenger cars" came 1st, 3 prefectures for "light and small passenger cars", and 1 prefecture for "parts for driving, transmission and operating units", adding up to 8 prefectures.

For the commodities from 2nd place on, as with the electronic communication-related products, automobile-related products were all top ranked in each prefecture.

Furthermore, "medical product preparations, including non-medicine preparations", "gasoline", and "tobacco" are also top ranking commodities (Table 5).
