

# Summary

This summary provides the number of manufacturing establishments and the value of shipments by product from establishments with four or more employees, as well as their ranking by prefecture, out of the results of “the Census of Manufacture 2012” carried out as of December 31, 2012.

## 1. The number of manufacturing establishments

In terms of the number of manufacturing establishments, the commodity category “Offset printing for paper” accounts for the largest number, followed by “Miscellaneous fabricated plate and sheet metal products”, “Miscellaneous processed foods”, “Fresh concrete”, “Miscellaneous fabricated construction-use metal products”, “Japanese-style pastries and cakes”, “Parts, Fittings and accessories of metal working machines”, “Plastic products for automobiles”, “Stamped and pressed machinery parts,” and “Miscellaneous seafood products”. This suggests firms related with food products and fabricated metal products are showing up at the top of the list.

As for location, Tokyo, Osaka, and Aichi have a lot of plants belonging to “Offset printing for paper”, which suggests that these three prefectures occupy a little more than 30% of the total. Aichi, Osaka, and Kanagawa have many plants in the “miscellaneous fabricated plate and sheet metal products”, accounting for almost 30% of the total (Table 1).

## 2. Value of product shipment

In terms of shipment value, commodity categories that show up at the top of the list include automobile-related products, such as “Ordinary passenger cars, 2000 ml cylinder capacity or more, including chassis” (hereinafter referred to as “Ordinary passenger cars”), “Parts of driving, transmission and operating units”, “Motor vehicle parts and accessories, including motorcycles”, “Light and small passenger cars, less than 2000 ml cylinder capacity, including chassis” (hereinafter referred to as “Light and small passenger cars”), “Parts of chassis and bodies”, “Trucks, including tractors”, fuel oil related products such as “Gasoline”, “Light oil”, “Heavy fuel oil C”, “Kerosene”, as well as “Medical products preparations, including preparations outside medicines” and “Offset printing for paper”. In addition, shipment values of electronic parts, devices and electronic circuits including “Electric parts, device and electric circuit, n.e.c.” and “Liquid crystal panel” also stand at a high level (Table2).

### 3. Top Products by Prefecture

#### (1) Number of Manufacturing Establishment by Products

Looking at the product category with the largest number of manufacturing establishments by prefecture, “Offset printing for paper” ranked first in 25 prefectures, the largest number of prefectures, followed by “Boards less than 7.5 cm depth of minimum cross section, with more than 4 times width larger than depth” and “Japanese noodles” in 3 prefectures each, and “Miscellaneous seafood products”, “Plastic products for automobiles”, “Miscellaneous fabricated plate and sheet metal products”, “Japanese-style ceramic tableware” in 2 prefectures each.

Local specialty products rank first in many prefectures such as “Miscellaneous seafood products” for Hokkaido which includes seafood delicacies and marinated seafood, “Frames” for Fukui, “Precious metal accessories, including jewel, ivory and turtle products” for Yamanashi, “Green tea (finished)” for Shizuoka, “Japanese-style ceramic tableware” for Gifu and Saga, “Socks” for Nara, “Vegetables pickled or in brine, including fruits pickled or in brine” for Wakayama, and “Semi-finished green tea” for Kagoshima. These prefectures rank high in the product’s prefecture ranking as well (Table 3).

## (2) Value of product shipment

Looking at the product category with the largest value of product shipment by prefecture, “Gasoline” ranked top in 8 prefectures, “Medical products preparations, including preparations outside medicines” in 7 prefectures, “Ordinary passenger cars” in 4 prefectures, “Cigarettes, cigars and pipe tobacco” and “Steel cargo shipbuilding, power vessel 20 gross tonnage or more” in 3 prefectures each.

Automobile-related products ranked top in a total of 8 prefectures, 4 prefectures for “Ordinary passenger cars”, and 2 prefectures each for “Light and small passenger cars” and “Parts of driving, transmission and operating units”. Electronic parts, devices and electronic circuits ranked top in a total of 5 prefectures, which include 2 prefectures for “Liquid crystal panel” and others.

Local specialty products such as “Baked rice confections” and “Low-class distilled spirits” ranked top in 2 prefectures (Table 4).
