- 1 Tick the square which corresponds to the type of document issued (export, re-export, import or other).
- Complete name, address and country of the importer. The name of the country must be written in full.
- Complete name, address and country of the exporter/re-exporter. The name of the country must be written in full
- 5a. The following purpose codes should be used:
