

Summary

I. Statistical Table on Enterprises (those with establishments of 4 or more employees)

The Statistical Table on Enterprises indicates the activity status of establishments engaged in the manufacturing industry with 4 or more employees by computing data after reclassifying it per enterprise unit to which each establishment belongs.

The number of establishments engaged in the manufacturing industry with 4 or more employees in 2006 was 258,543 (down by 6.6% compared to the previous year), and if these establishments are recounted on an enterprise-unit basis, the number of enterprises were 234,579 (down 7.1% id.) (Table 1).

1. Number of enterprises

Looking at the number of enterprises (234,579) in terms of management structure, the number of enterprises of corporate organization was 198,381 (down by 4.5% compared to the previous year), accounting for 84.6% of all enterprises. The number of enterprises established as an association or others was 1,987 (down by 5.4% id.), accounting for 0.8%, while the number of privates enterprises was 34,211 (down by 20.1% id.) accounting for 14.6% (Table 1, Table 2).

Figure 1 Changes of the Number of Enterprises per Management Structure



The number of enterprises which have one establishment was 219,184 (down by 7.5% compared to the previous year) of all enterprises (234,579), accounting for the most of all entire enterprises at 93.4%. The number of enterprises with 2 or more establishments was 15,395 (down by 1.4% id.) accounting for 6.6% (Table 2).

2. Number of employees

The number of employees was 8,225,442 (up by 0.8% compared to the previous year). On a management structure basis, the number of employees of corporations was 7,943,497 (up by 1.4% id.) accounting for 96.6% of the total. The number of employees of associations and others was 57,666 (down by 4.3% id.), accounting for 0.7% and the number of employees of privates enterprises was 224,279 (down by 15.5% id.) accounting for standing at 2.7%. Figure 2 Changes in the Number of Employees per Management Structure



Furthermore the number of employees in enterprises with one establishment was 4,514,768 (composition ratio in all enterprises: 54.9%), down by 1.0% compared to the previous year and the number of employees in enterprises with two or more establishments was 3,710,674 (45.1% id.), up by 3.1% id. Looking at the composition ratio by size of capital, in corporations with capital less than 10 million yen, the ratio of the enterprises with one establishment was almost all (The composition ratio in all enterprises with capital less than 10 million yen was 95.3%). While in the corporations with capital more than ten billion yen, the ratio of the enterprises with 2 or more establishment was extremely high (The composition ratio in all enterprises with capital more than 10 million yen was 94.8%) (Table 4) .

3. Shipment value of products, etc.

The value of manufactured goods shipments (hereinafter referred to as “shipment value”) was 314 trillion 834.6 billion yen (up by 6.6% compared to the previous year), showing an increases. In terms of management structure, shipment value of corporations was 312 trillion 470.6 billion yen (up by 6.6% id.), accounting for 99.2% to the total, that of associations and others was 1,149.5 billion yen (down by 4.1% id.), accounting for 0.4% and that of privates was 1,214.5 billion yen (down by 13.3% id.), accounting for 0.4% (Table 5, Table 6).

Figure 3 Changes of “Shipment Value” per Management Structure



Shipment value in enterprises with one establishment was 105 trillion 633.4 billion yen (up by 3.8% id.), accounting for 33.6% and shipment value in enterprises with two or more establishments was 209 trillion 200.9 billion yen (up by 8.1% id.), accounting for 66.4% to the total (Table 6).

Further the enterprises with one establishment was almost all of the number of them (the composition ratio 93.4%), and they account for more than half at 54.9% in terms of the numbers of employees, and they account for 33.6% in terms of shipment value.
